# **COT Office of Equity Update** – Jay and Laurice:

-Laurice spoke about demographic data, equity index and the Equity Action Plan and how these are used from the data collected and used around the city. Jay spoke about using the mapping project and measuring equity going forward so the city can understand if we're improving equity or not and that the mapping project really creates a baseline in framework, as a subcommittee and full commission how we can bridge the gap between HCD and other departments that are dealing with housing to use this great tool that has been developed to start that measurement process so equity can be measured year to year.

-Laurice talked about the draft of the Equity Implementation Plan and how that plan came about and now that draft is in with a consultant team in finalization phase and will be brought back to the subcommittee for review and any additional feedback. Hopefully by next spring each department within the city should have their own individual department specific Equity Plan.

**COT HCD UPDATES** – Lena updated on P-CHIP and a feedback form is available with the draft plan and opened until September 24<sup>th</sup> for public feedback, she shared the link in the chat. She shared the draft definition on Equity in Housing and asked for feedback from the members. Lena will email all members for any feedback. Jay shared the definition of equity from CEHD's webpage of shared language.

-Ernesto updated that a 1.5-million-dollar grant awarded to HCD from Choice Neighborhood Planning Grant from HUD will be directed to support the 29<sup>th</sup> Street Thrive Initiative. This is the 3<sup>rd</sup> highly competitive HUD Choice grant that the city has received, the first two were directed to the Thrive in the 05 project.
