2. Approval of Minutes – (Vote) – 5 minutes

3. Call to the Audience (First) – 5 minutes

Allen Benz mentioned he was at Cyclovia talking with people regarding public transit. He said there is still quite a bit of interest in the zero fares for transit, with people filling in postcards to send to City officials.

Updates and Announcements from Committee Members and Staff (Informational Only) –
 NO ACTION TAKEN

Ray brought up that people in wheelchairs need to be secured by the drivers. In this case, the driver was helping secure Ray but people coming in did not wait and pushed against the driver, which is a safety hazard. This issue increased after the pandemic, with lack of fares playing a role because people don't have to wait at the front and pay.

Margot brought up the Sun Van survey that her daughter received and complimented the large format. She mentioned that they should add more information so that people know where to submit the survey once they have completed it.

Davita said the onboard survey has been completed. The surveyors collected 9,000 weekday surveys, 800/Saturday and 600/Sunday. The next phase is to process all the onboard survey and remove any identifying information, if needed.

Also, Sun Tran's Learn to Ride summer sessions (held at Sun Tran north yard) will be held the following days and times: Wednesday, April 9 at 10 a.m., Wednesday, May 14 at 1:30 p.m., Thursday, June 12 at 12 p.m.

Regarding bus stop maintenance, Sun Tran has a list of bus stops that need replacement and repairs. Staff are currently looking into the different types of replacements.

- 5. Complete Streets Coordinating Council Update 5 minutes

 Riley talked about the Safe Streets Mini Grants Program, a program for neighbors to propose safety measures such as chicanes, traffic circles, and speed humps, on residential streets. There was discussion regarding whether safety measures should be implemented across all Wards or to those with the highest need, regardless of Ward location. He also mentioned the Complete Streets Coordinating Council approved adding a shared-use path extension to the St. Mary's Road Pedestrian Safety & Walkability Project. The extension would include a new HAWK, connectivity to Safeway, & protected bike lanes on Silverbell.
