As of February 3rd, 2025, the City of Tucson is paying the company Steam Works approximately \$95k/month for cleaning services at the transit centers.

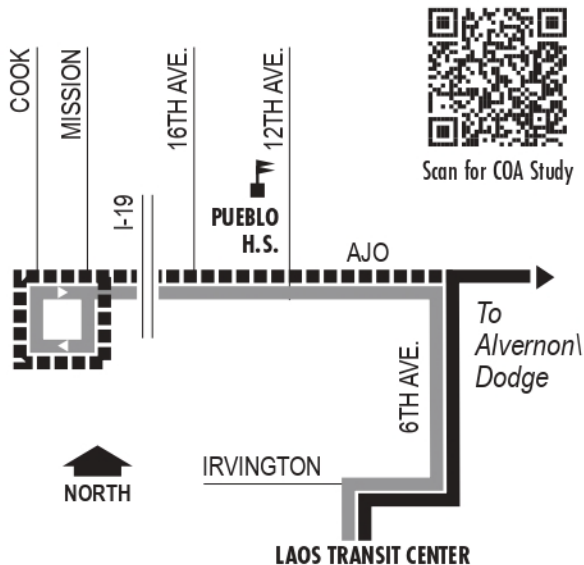


Attention Route 11 & 50 Passengers

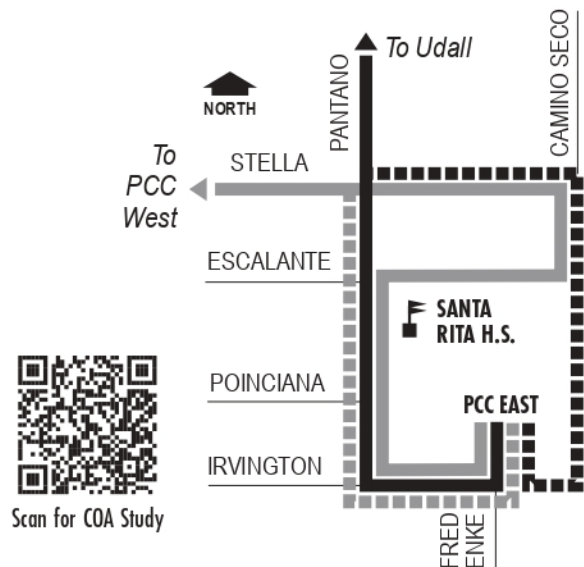
Attention Route 3 & 37 Passengers

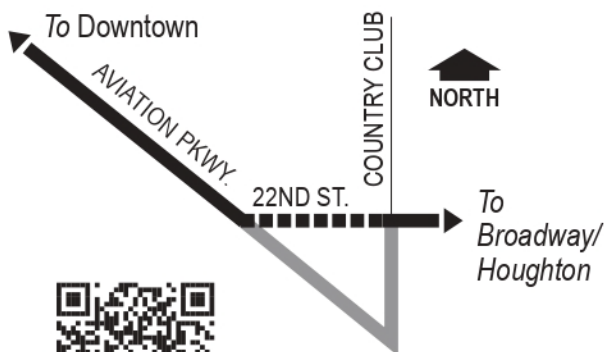


Attention Route 7 Passengers

8. Letter Inviting the Mayor's Office to Attend a TTAC Meeting - 15 minutes

ACTION APPROVED BY MOTION

Lisa Shipek drafted a letter to invite the Mayor's Office to attend a TTAC meeting. Mike M. said he will approve the motion of the letter if they remove the text that brings up that we support continuing with fare free service, especially in light of recent changes to federal funding. Lisa does not have a problem with rewording the letter, she said her original focus was on engaging the Mayor and her

vision, trying to interest the Mayor in attending. Gene doesn't think we should bring up the fare issue at all, because first we need to get the Mayor in the room, so that the TTAC can hear from her and so that she can hear from the TTAC. Next, Gene moved the motion of the modified letter, which was duly seconded, and, hearing no objections, Chair Suzanne approved the motion.

9. Call to the Audience (Second) – 5 minutes

- Allen Benz asked why we have the category of fares in the budget if we are not currently charging fares. He also brought up that there is a deficit that does not make sense. Rhett mentioned that was a misallocation and that the next budget presented to TTAC will be updated. Likewise, Allen talked about drivers on the 18 Route speeding on 6th Ave.
- Richard said he rode the #2 on Saturday, and he says his biggest fear is finding where he needs to go. He says the signs are awful, and that he is not the only person with this issue, he thinks that there is more that can be done to help people with disabilities.
