2. Approval of Minutes – (Vote) – 5 minutes

The approval of April minutes were tabled until the next scheduled TTAC as May meeting did not meet quorum and April minutes had not been printed, Chair Suzanne Schafer approved the motion.

3. Call to the Audience (First) – 5 minutes

NO ACTION TAKEN

Allen Benz – City and Sun Tran appear to be working on and addressing some of the issues he's seen lately at some transit stops, noting he'll follow up again but nothing specific for now.

4. Updates/Announcements from TTAC Members and Staff (Informational Only) – 10 minutes
NO ACTION TAKEN

Mikel Oglesby provided a brief update on the new transit app which is estimated to be ready in late August. Mikel also provided a brief update on the adopted COA changes and schedule for implementation.

Blake Olofson from Traffic Engineering provided an update on the challenges facing putting in a full traffic signal on Irvington Rd at Laos Transit Center to allow buses to turn left onto Irvington Rd. The primary challenge is budget – the cost is estimated at about \$800k and there isn't funding currently earmarked for this project. Rhett and Blake discussed coming up with a basic design to shop the idea around to try and get funding. Susan mentioned there may be funding available through Tohono O'odham grant but that a proposal would need to be submitted by June 5. Margot, Ray, Suzanne, and Gene all spoke in support of getting a signal here to support the continued presence and improvements at Laos Transit Center, as it serves a critical need for shelter from the weather for riders and efficient transfers.

Ian Sansom gave an update on the Sun Van COA. The draft report is expected to be complete by end of July, and there was discussion about including a longer Sun Van COA update once the report has been reviewed by TTAC, perhaps at a September meeting date.

5. Complete Streets Coordinating Council Update – 5 minutes

NO ACTION TAKEN

Riley Merline provided an overview of the May CSCC. The CSCC had discussions around the proposed Drexel Rd redesigns, and pushed for a 2 lane version over the 4 lane version. Mackenzi and Shamara provided a presentation about transit stops and Complete Streets design. The CSCC voted in support of updating the Major Streets and Routes (MS&R) plan.

6. Route 5 Reevaluation Overview – 5 minutes

ACTION APPROVED BY MOTION

Shamara Smith gave a summary of the recent outreach around the proposed Sun Tran Route 5 and Route 22 changes (see PPT included below).

Following the presentation, Gene read through a prepared letter in support of keeping Route 5 that was also sent to the TTAC and Mayor and Council. Among the reasons Gene gave in opposition of eliminating Route 5: the route is one of only a few that cross the city East-West, the route serves numerous schools, including the School for the Deaf and Blind, and serves the Pima corridor, which is a half mile from parallel routes. Gene supports cutting the Route 22 instead of Route 5 which doesn't serve a clear purpose and appears to be a relic from a previous need for a loop around El Rio, and Margot concurred and said that the route also connects to the Udall center which is a cooling center and that many older adults would be impacted by the removal of Route 5. Gene mentioned that ultimately cutting frequency should have been considered rather than cutting an entire route out of the system.

Suzanne asked if there were other proposals and if the TTAC could see those other proposals. Suzanne also asked if there can be thought put into how the City collects, processes, and analyzes public comments, as it seems to mostly be in raw form through comment cards, which are difficult for council to easily process. Suzanne also mentioned the need to emphasize and adequately capture live comments as people make considerable effort to attend in-person events. Margot mentioned there are several methods to collect and organize large numbers of comments for analysis.

Gene called a motion to formally oppose the elimination of Route 5. The motion passed 7 to 0.

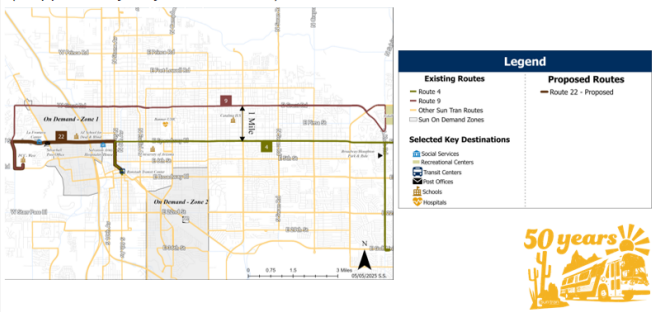


Proposed Routes – Route 5 and 22

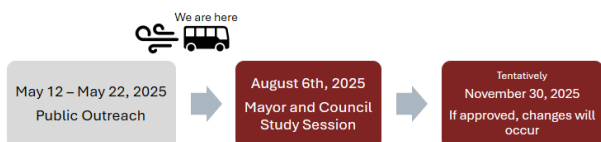

Increase the stock of zero-emissions, battery-powered transit to 90% by 2030.

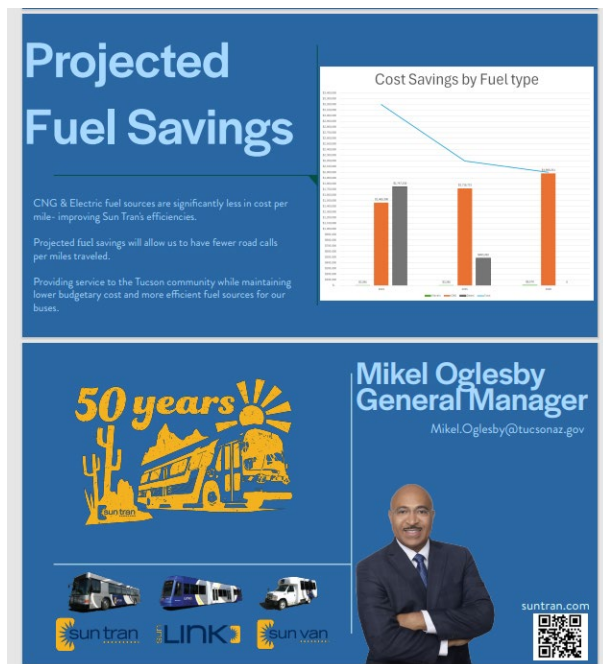
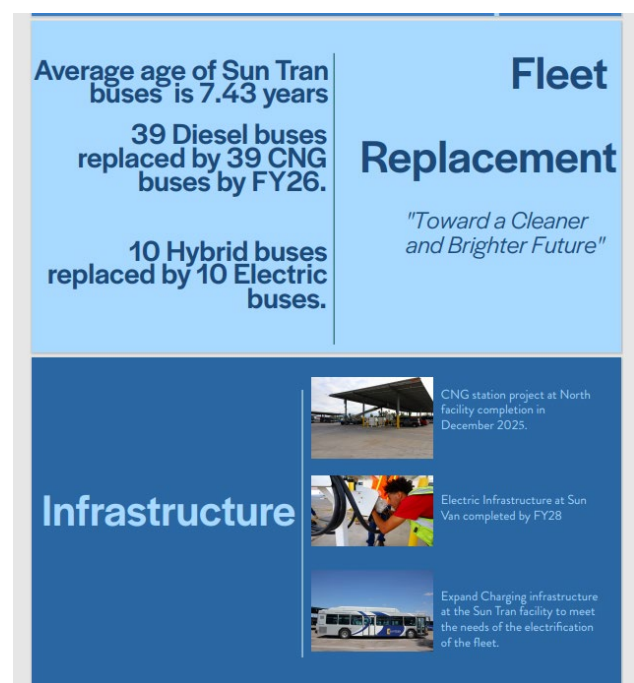
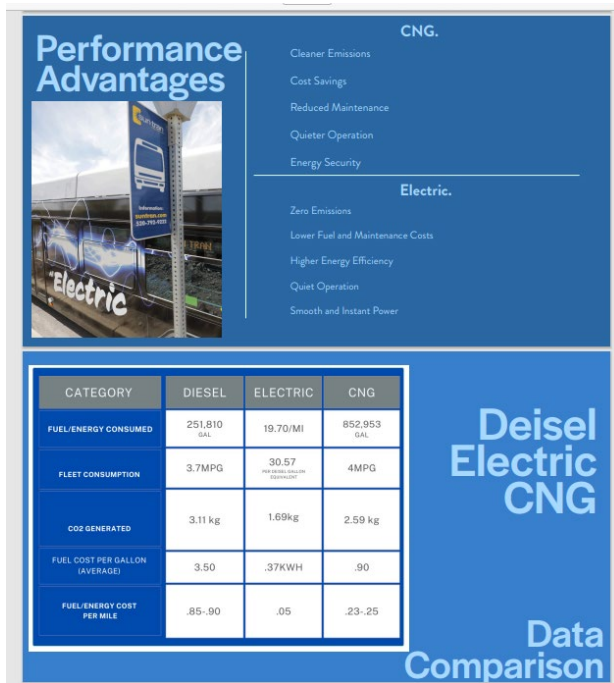
Invest in the charging infrastructure needed to support EVs in the City fleet and provide adequate workplace charging for municipal employees.

Increase awareness and use of personal EVs among City employees.

Sun Tran Alternative Fuel Goals

- Achieve fleet reliability comparable to or better than the current fleet with diesel buses.
- Lower operational cost achieving a 30% reduction in overall operating cost within 5 years of converting to 100% of the fleet being CNG and EVs.
- Transition the remaining 26% of the fleet to CNG & Electric.
- Reduce emissions of pollutants such as NOx to improve public health.
- Partner with Tucson Electric Power and other agency's to reduce energy cost.

Sun Tran will meet our goal of 100% cleaner burning fuel in FY26 in alignment with the City of Tucson's Climate Action Plan!



8. Call to the Audience (Second) – 5 minutes

Gene provided a letter and went through the merits for considering Electric Trolley Buses (ETBs) in Tucson. Mikel commented that he had experience with these in Boston and liked the idea, Ray also had positive experience with ETBs in Boston. Suzanne asked how best to move forward, and Gene said it would need council support and asked that TTAC members use the letter as a basis to propose the idea to see if it can gain traction or interest. Mikel mentioned they would need to do a study on feasibility.

Allen Benz reminded everyone that the RTA board is having a meeting this week and it will be livestreamed.

Ray Jordan mentioned that he's lived in other places where buses had clear right of way when pulling out of bus stops or bus bays, and he'd like to see a movement here to improve driver training around bus right of way.
