- 3) Announcements—Chair Juneman requested that the two new members, Dennis Canty and Claire Zuckers, introduce themselves, share their interests in CWAC, and share their background.
- 4) Review and approval of September 10, 2025, Legal Action Report and Meeting Minutes Motion: Member Forrest moved to approve the Legal Action Report & Meeting Minutes. Member Ellet duly seconded the motion. Discussion: None. The motion passed on a voice vote, 9 0.

- 5) **Director's Report** Tucson Water Deputy Director Silvia Amparano provided brief updates as follows:
  - a) Mayor and Council items:

  - c) Water Demands
  - d) UCAB 30<sup>th</sup> Anniversary
  - e) Large Water Users Ordinance Update

Members asked questions, and Deputy Director Amparano fielded them throughout her report to clarify information for the committee and provide updates on water matters.

6) Capital Improvement Program Update FY2025-2026 – John Van Winkle, Tucson Water Administrator and Chief Engineer, provided the committee with an update on key infrastructure projects, rehabilitation efforts, and program enhancements across Tucson Water's system. Highlights included progress on well drilling and equipping, reservoir rehabilitation, and main replacement projects that prioritize aging infrastructure and system reliability. Completed and ongoing projects such as the La Paloma Reclaimed Reservoir rehabilitation, the Kolb Reservoir design phase, and the Sahuarita Supply Line Slip Liner were discussed as part of Tucson Water's ongoing investment in maintaining service capacity and operational resilience. The presentation also emphasized process improvements within the CIP program, including implementation of Energov, a project life-cycle tracking tool expected to launch in early 2026, which will streamline coordination across design, construction, and capitalization phases.

7) **FY25 Year End Review Preliminary & Unaudited** – Kim Baker, Rates and Revenue Manager, provided the committee with Key highlights, including comparisons of budgeted versus actual expenses across major funding categories, such as the General Water Fund, GSI Fund, and Conservation Fund. The report outlined spending patterns related to operations and maintenance, Capital Improvement Projects (CIP), professional services, repairs and maintenance, and debt service.

No action was taken on this item.

- 8) **Human Resources Update** Munera Acosta, City of Tucson Human Resources Manager, gave the committee an update on the vacancy rates. The committee proceeded to an active discussion of vacancies, hiring capacity, and staff wages.

- 9) **Subcommittee Reports** Chair Juneman reminded the committee of the previous subcommittee discussions, the continued vacancy on TPP, and the difficulty in filling the vacancies on all of the subcommittees. Staff provided a single option to create a CWAC working group that combines all the subcommittees into a single group. The committee

discussed and agreed to return in November to remove TPP and require all members to join a subcommittee.
