El Pueblo Housing Nonprofit Corporation, pursuant to the Bond Application, has requested that the Tucson IDA issue its multifamily housing revenue bonds, in one or more tax-exempt and/or

taxable series, in an aggregate principal amount not to exceed \$20,000,000.

KG Development, pursuant to the Bond Application, has requested that the Tucson IDA issue its multifamily housing revenue bonds, in one or more tax-exempt and/or taxable series, in an aggregate principal amount not to exceed \$40,000,000.

# 5th Item: Possible Action: Exclusive Negotiation Agreement

KG Development has requested that the Tucson IDA enter into an Exclusive Negotiating Agreement for the parcels at Stone and Council. The developer has provided Tucson IDA with a proposal to build a mixed-use project on the property that will include approximately 200-250 affordable multi-family units.
