3. Updates from Law Enforcement.

Status report from the Tucson Police Department (TPD) regarding any recent or upcoming bicycle-related actions or activities. Questions for TPD representatives.

Discuss with Law Enforcement – plans to address safety issues on the Loop – motivated also by recent bicyclist stabbing / death on the Loop near Mall's Diamond Street Loop.

Law Enforcement please stay for the next discussion point on Hawk signals.

4. Updated discussion: Are HAWK lights really the best / safest option? 10 min/6:30

- Ask law enforcement on bicyclist (and pedestrian) fatalities / accidents statistics at Hawk signals.
- At least two bicyclist fatalities occurred in Tucson in the recent past (one just in the last few days). And what is the statistics about pedestrian safety at Hawk Signals? https://www.kold.com/2025/11/17/bicyclist-dies-after-crash-tucson/
- The recent triple fatal pedestrian crash at Euclid and 2nd Street also prompts request for a Hawk signal there.

- But is Hawk really the best option? Many bicyclists report cars not properly stopping (Personal experience: ~2% of all Hawk crossings one car runs on red.) https://www.bicycletucson.com/all-posts/bicyclist-struck-last-week-dies/27370
- As potential alternative: What about a regular looking traffic light that is always green and turns red when requested?
- Robust studies comparing Hawk safety (and overall traffic flow) to other options appear still sparse.
- Likely to be followed by another future discussion also with traffic engineers

5. Presentation by Lee Miller (DTM) on East Side Bicycle Networks 30 min/6:40Lee Miller (DTM) will give presentation to the BAC on the east side bicycle networks.

East Side Bicycle Boulevard Network project

Recent updates on Sarnoff Drive prompted some local news articles of whether new bicycle infrastructure is appropriate (see article below): One could summarize that (on one hand) various physical objects allow for better separation between cars and bicyclists (and pedestrians) and are based on newer safety guidelines (according to engineers), while (on the other hand) others (like car drivers, local businesses, etc.) find it confusing and also harder to find parking spaces etc.

Daphne Hope also questioned whether BAC input was properly requested at the time (not clear – as this was a while ago.)

8. Discussion letter to UofA for deterring bike theft

9. Bicycle infrastructure West of Santa Cruz River / N Silverbell road 10 min/7:40 Does the committee want to address the constituent's request to install bike lanes on both sides of El Camino Del Cerro west of Silverbell Rd, near Sweetwater Preserve? (Chair leads the discussion)

Based on google maps and bike map consultation: It appears that this is a two lane road with dirt on the side. Bicycles currently have to be on the street, and cars would have to cross two opposite lane to overtake bicyclists. Both lanes are (everywhere) separated by two yellow lines, i.e., cars cannot legally overtake bicycles. The whole stretch is about 1-1.5 miles. Sand gravel to two both sides of the streets is rather unsuited for regular biking. At an estimated 20% it is likely impossible to bike / walk to the side of the regular street (either very loose sand – or earth 1-2 feet high).

Assessment: This road is currently not safe / suitable for bicycling at all. Adding proper bike (and walking) paths to either one or both sides is mostly possible, would likely

require some earth work as well. An alternative bike path close by (e.g., on a parallel street) is not apparent; google maps suggests some "wild food paths" – but not clear how those are related to the local properties.

Potential course of action:

- BAC committee might discuss / vote that a safe bike (and pedestrian) infrastructure is desirable there
- Do we have any assessment of how many people would use this path on a regular basis / and how it would potentially integrate with work/school commute as well as recreational cycling/hiking in the local mountains.
- Request city to provide a first assessment of what it would take (cost/time) to add proper bike (and walk) infrastructure there and how this would land on the overall priority list
- Request city for a more general update on plans for bicycle infrastructure into the west of Santa Cruz river / N Silverbell road

10. Bike Culture in Tucson: Next actions from BAC?
