Presentation from DTM Planning Administrator Patrick Hartley for a funding request for the construction of 6 HAWKs, to supplement the existing federal funding from the Highway Safety Improvement Program (HSIP).

A discussion was held, and a motion was made by co-chair Sophia Gonzelez, duly seconded, to approve \$500K in Prop 411 Safety funding to support six HAWKs to leverage federal funds; all approved.

This item was a continuation from the October 22 CSCC Meeting and included an update on member check-ins with their appointing agencies and a discussion of drafting a letter related to the RTA Next initiative. This included an overview of the policy statement released by LSA (speaker Vanessa Cascio) and clarifying information related to RTA Next by DTM Administrator Patrick Hartley.

A discussion was held, and a motion was made by co-chair Marshall Davis, duly seconded, to form a subcommittee to draft a letter in response to the RTA Next initiative; all approved.
