Tucson IDA enables strategic, economic, and community development by providing financing and access to capital for projects and programs that benefit a thriving Tucson.

2nd Item: Approval of the Tucson House Multifamily Housing Revenue Construction/Permanent Notes (Tucson House Project), Series 2025, to be issued from time to time, pursuant to a plan of financing, in one or more tax-exempt and/or taxable series in an aggregate principal amount not to exceed \$102,500,000.

The Board discussed yesterday's visit to Tucson House and the size of the financing. Board members asked the General Counsel to describe the next steps in the public approval process and closing timeline, which will involve final Mayor City Council discussion and approval in October, with the transaction expected to close by November. The Board discussed the project's construction schedule, which is expected to begin at the end of the year.

Mimi Petro moved to authorize and approve the issuance of the Notes, in an aggregate principal amount of not to exceed \$102,500,000 on the terms and conditions set forth in, and subject to the limitations specified in the plan of financing, and authorize and direct the Board President or Secretary, on behalf of the Board and for and in the name of the IDA, to execute and deliver the Final Approval Resolution and Documents in the form submitted to this meeting, with such changes, insertions and omissions as the IDA's Bond Counsel and General Counsel may require or approve.
