Review and Adoption of January 15, 2025, Meeting Minutes

Call to the Audience

2. City and County Updates:

A. HCD Updates –

Ann Chanecka reported that Mayor and Council adopted an Emergency Housing and Homelessness Declaration this week. An ordinance and resolution were approved. The declaration allows 90 days to develop a formal process for safe parking and safe outdoor sites and may include waivers and accommodations to facilitate emergency shelters and related uses. Additional details will be provided to the Commission in the coming months.

She thanked Commissioners who participated in the Point- in-Time Count and acknowledged the work of the Continuum of Care and TPCH. She also announced upcoming spring community engagement meetings related to housing projects and shelters. Information will be distributed.

C. Pima County Updates-

Sofia Blue reported on General Fund Gap Funding recommendations. Eighteen proposals were received requesting over \$16.5 million; \$5 million was available. Several projects were recommended for partial funding and will be presented to the Board of Supervisors on February 17.

Ms. Blue also provided a brief overview of the Draft 10-Year Regional Housing Strategy, which outlines five goals, 27 strategies, and an estimated \$413 million funding need. The plan will move forward for endorsement and Board approval.

3. Home Gap Funding Scoring –

- Andrew Paredes, Community Development Administrator, presented the HOME Gap Funding scoring process. Eight applicants will present proposals to the Commission for project impact scoring. One Commissioner disclosed a conflict of interest and recused.

Score sheets will be distributed following the presentations, with scores due February 10. Commissioners were advised that no questions would be permitted during presentations, as the exercise is limited to listening and scoring.

4. Tenants' Rights to Counsel-

Alan Solot, Southern Arizona Legal Aid, presented on a proposed Tenant Right to Counsel (RTC) program, outlining eviction data, legal representation disparities, and projected cost and community benefits. He requested that the Commission recommend the City explore establishing RTC.

Following discussion regarding jurisdiction and funding considerations, the Commission voted to recommend that Mayor and Council consider Tenant Right to Counsel. The motion passed unanimously, with no nays or abstentions.
