2. Invocation

The invocation was given by Chair Kary.

3. Introduction of Guests – Update/Discussion

a. **Maria Nguyen, Southern Arizona Veterans Health Care System**

Ms. Nguyen started by informing the committee her time as Interim Director with the Southern Arizona VA Health Care has come to an end due to VA policy and now Dr. John B. Kettele will take over the position. Ms. Nguyen highlighted some of the topics from the SAVAHCS March 2026 Director’s Report which included the Fisher House 10th

Anniversary Car Show and Resource Fair, the Adaptive Recreation Clinic at the VA main campus and the Tucson Veteran Engagement and Resource Fair. Ms. Nguyen reminded the committee it is tax season and the VA does offer free tax preparation for veterans. Ms. Nguyen provided an update on the scam alert the VA issued a warning about last month, informing the committee fraudulent letters are also being mailed out to veterans requesting payment for future services, she advised the VA will never request payment for future services or appointments. Ms. Nguyen also informed the committee the VA is still looking for volunteer drivers to drive veterans from Yuma and Sierra Vista to and from medical appointments. Ms. Nguyen concluded by providing an update on the renovations and expansion of the emergency department at the Tucson VA.

h. Jonathan Kary, CBP Veteran Service Program

Mr. Kary spoke to the committee about the CBP Veteran Service Program which employs over 24,000 veterans. Mr. Kary also assists military members in transitioning from the military to federal civilian careers.

i. Tanya Morrison, Arizona Veterans Memorial Cemetery

Ms. Morrison provided an introduction on herself and gave a brief description of the Arizona Veterans Memorial Cemetery and their locations, reporting they have interred 5,847 Veterans and eligible dependents in their facilities, with 71 of those interred being from February 2026. Ms. Morrison also shared the "Missing in America Project" is coming up on Saturday, April 18, 2026, starting at 10 a.m. Commissioner Ruiz shared it was the 10th Anniversary of the Arizona Veterans Memorial Cemetery in Marana.

Discussion was held, and no formal action was taken.

4. Approval of Legal Action Report for February 11, 2026

The motion was moved by Commissioner Byron, duly seconded by Commissioner Ruiz, and passed by a roll call vote of 9 to 0 to approve the Legal Action Report.
