**3. Subcommittee Purpose and Policies**

Clarification on local and state policies that affect the subcommittee's work presented by Comm Bachmann, to include discussion on the City's Website/Social Media policy from 2017 and Open Meeting Law.

Comm Bachmann confirmed that tabling at events is allowed, per Boards and Commissions, so long as business is not discussed and legal actions are not deliberated on at the event. Event details must be shared with Boards and Commissions beforehand to be posted to the City website.

Comm Brown reminded commissioners that they draft Public Notices for Boards and Commissions to post to the City website, including events we are expecting to table at. Comm Brown recommended we make sure to report the events we plan to table at during our CCES monthly meetings so they are recorded in the minutes for the public to see in advance.

Comm Bachmann confirmed reports can be included as addendum to our commission meeting minutes. City Staff Member Michael Catanzaro shared there is a section on the City website for Reports. This is where commission Annual Reports are generally posted, but Mr. Catanzaro agreed to ask Boards and Commissions if we can upload other reports there as well.

Comm confirmed reports and other commission information can be shared directly with their appointed City official.

Comm Brown confirmed the PCC Climate Community Day is scheduled for Tuesday, April 21. Comm Brown offered to speak with the organizers to get the subcommittee a table, but Comm Bachmann said she would speak with Fatima Luna, Chief Resilience Officer, first to see if the City plans on tabling so we can partner at the event. Comm Bachmann will follow up.

Comm Shepp shared that Cyclovia is scheduled for Sunday, April 12 from 9am to 3pm. Comm Shepp said this would be a great event for our subcommittee to table at considering high public participation. Comm Shepp agreed to contact the organizers, Living Streets Alliance, to find out if they are willing to let us table for free (as there is usually a cost associated).

Commissioners discussed the purpose of the subcommittee. They identified the need to raise awareness about the commission among the public, and make sure our appointers know we are available for requests. Discussion will continue at the next subcommittee meeting.
