6. Tucson Police Department:

A. TPD Updates regarding events or developments relating to TPD during the prior month

Tucson Police Department Captain, Adam Kidd provided a brief overview of the Aerial Emergency Response (AER) Platform. The program is a one-year pilot initiative designed to respond to active 911 calls for service and is not intended to function as a proactive surveillance platform. The AER unit will respond only to active 911 calls.

The program is expected to arrive on scene within approximately 2–3 minutes for most calls, which is significantly faster than typical patrol response times. It is intended to assist in directing units more efficiently and to provide patrol officers with real-time awareness of when additional resources may be needed.

All flights will be logged and subject to audit, with logs available for review by the community through automated processes. There is currently no official launch date. An in-depth presentation is scheduled for the July 23, 2026, CPARB meeting.

B. Office of Professional Standards/ Updates regarding events or developments relating to the Office of Professional Standards during the prior month.

There were no reports presented.

7. Office of Independent Police Auditor

There were no reports presented.

8. Possible Ordinance/Tucson Code Changes regarding the future of the Community Police Advisory Review Board (CPARB) direction (Discussion/Action).

Possible ordinance code changes were previously reported under item number three. At the June 23, 2026, Mayor and Council meeting, an ordinance will be considered to extend CPARB member terms and potentially eliminate the eight-year term limit. The item may be presented for discussion or placed on the consent agenda, depending on how it is classified by the Clerk's Office, City Attorney, and Mayor and Council.

9. CPARB Vacancies.

Regarding CPARB vacancies, potential changes are being reviewed, and updates will be provided as they become available.

After a resignation memo, CPARB members stated that they have the Mayor, Wards 1, 2 and 6 vacancies.
