3. Bear Canyon Neighborhood Plan Amendment Public Hearing

A motion to close the public hearing was made by Commissioner Martin and seconded by Commissioner Zegeer. The motion carried by a voice vote of 8-0 (Chair Wellott and Commissioners Huarague, Schwartz, and Lampo absent).

Discussion held.

A motion was then made by Commissioner Casadei to recommend in favor of an exception to Section g of the Bear Canyon Neighborhood Plan stating that Parcels 114-51-200B and 114-51-200C are exempt from Implementation Technique 11.g, so long as the parcels are used as an express car wash. The motion was seconded by Commissioner Martin. A friendly amendment was then made by Commissioner Kinney to Commissioner Casadei's original motion.

The friendly amendment was accepted by Commissioner Casadei and seconded by Commissioner Martin.

The Commission voted by roll call 6-2 (Commissioners Pafford and Zegeer Dissented, and Chair Wellott and Commissioners Huarague, Schwartz, and Lampo absent) in favor of the recommendation to the Mayor and Council, with the following revised language:

"Moved to approve an exception to Section 11.g. of the Bear Canyon Neighborhood Plan stating that Parcels 114-51-200B and 114-51-200C are exempt from Implementation Technique 11.g, so long as the parcels are used for

an express car wash, and subject to the following all uses with an express car wash are to be screened from adjacent property and streets by landscaping and decorative fencing or masonry wall.”

Per the Unified Development Code, Section 2.2.3.B.3, “a concurring vote of seven members is necessary to make a recommendation to the Mayor and Council.” Therefore, the amendment proceeds to Mayor and Council without a recommendation from the Planning Commission.
