1. Call To Order

A quorum for the whole of the Southern Arizona Education Council was met. The meeting was called to order by Marla Franco at 10:06 p.m., with Rocque Perez, Karla Silva, Jennifer Vasquez, Dustin Williams, Lane Santa Cruz, and Irene Robles-Lopez present.

The consent agenda was presented by Rocque Perez who invited a motion to approve. A motion to approve the consent agenda invited by Rocque Perez, so moved by Jennifer Vasquez, and seconded by Marla Franco. A unanimous vote was in favor.

3. Program Report and Approval of 2026-2027 Budget

The program report was presented by Rocque Perez with discussion on promotional opportunities for respective events. The associated budget was presented by Rocque Perez with comparative insights between amended FY 26 and proposed FY27. A motion to approve the 2026-2027 budget was invited by Rocque Perez, so moved by Marla Franco, and seconded by Karla Silva. A unanimous vote was in favor.

4. Proposed Southern Arizona Education Council Resolution 2026-001

- A resolution of the Southern Arizona Education Council requesting amendment of Pima County Resolution No. 2025-48 and City of Tucson Resolution no. 24041 to remove Santa Cruz County from the formal governance and membership structure of the council and to revise the status of the chief executive officer for clarity in governance and compliance with applicable law.
 - The proposed amendments to City Resolution No. 15453 and County Resolution No. 1990-178, included herein as *Exhibit A*.

The resolution was presented by Rocque Perez with discussion on delineation of past and proposed amendments, the process for its implementation, and the aspiration for future collaborations with Santa Cruz County to re-engage on their originally intended inclusion within the organization's structure. A motion to approve Resolution 2026-001 was

invited by Rocque Perez, so moved by Dustin Williams, and seconded by Lane Santa Cruz. A unanimous vote was in favor.

5. Proposed Southern Arizona Education Council Resolution 2026-002
 - a. A resolution of the Southern Arizona Education Council in opposition to 2026 legislative ballot referrals affecting the educational welfare and wellbeing of learners, educators, and the institutions that serve them.

The resolution was presented by Rocque Perez with discussion on the historical role in legislative advocacy, the process in which the individual ballot items are considered in the whole of approval, and the use of the organization's funds outside of municipal allocation. A motion to table Resolution 2026-002 was invited by Rocque Perez, so moved by Dustin Williams, and seconded by Jennifer Vasquez. A unanimous vote was in favor.

A motion was invited by Rocque Perez, so moved by Dustin Williams, and seconded by Karla Silva. A unanimous vote was in favor. The meeting adjourned at 10:53 a.m.
